	Term End Examination	40	Term end examination will comprise of four (4) short answer type questions and four (4) long answer type questions of 3 rd and 4 th units. The student shall be required to attempt at least two questions from short answer type and two questions from long answer type questions with a word limit of 100-150 and 300-400 respectively. Short answer type questions will carry seven (07) marks and long answer type questions shall carry thirteen (13) marks each respectively. <ul style="list-style-type: none"> • Short Answer Type Questions = $2 \times 07 = 14$ Marks • Long Answer Type Questions = $2 \times 13 = 26$ Marks
