The scheme for commerce given in the notification No. F(Sub. Com. CBCS-UG)Acad/KU/16 dated 22-03-2016 and the UGC B. Com CBCS Scheme is adopted with the following observations. The proper procedure for formulation of the scheme and syllabus should have been followed, the spirit of which was highly democratic and participatory. There are some courses with 5 units (6 credits) carrying 100 marks, 6 units (6 credits) carrying 100 marks, 3 units (100 marks). There is no uniformity in allocation of credits as well as marks. The contents of the syllabus are irrelevant. Instead of MIL Core Commerce Course should have been prescribed. The Financial Economics courses should be rechristened as monetary economics.
