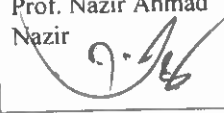
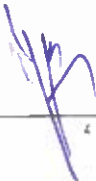
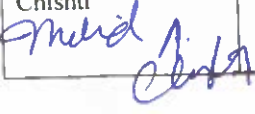

Item 4: University Scholarship:-

The matter of the Ph.D. University Scholarship was discussed in light of the University governing scholars guidelines and, subsequently, it was resolved that the scholarship shall be recommended as per the set criteria for the years. However, the Department shall seek fresh applications against the vacant positions from all the enrolled scholars except from those who are availing or have availed the University scholarship for three years or who are availing or have availed any other research scholarship. Moreover, the scholars who are been granted the University scholarship shall be given extension for 2nd & 3rd years subject to submission of satisfactory performance progress report of scholar from the concerned supervisor.

Furthermore, on the behest of the DRC the HOD approached the Office of Dean Research to clarify the matter for any ambiguity regarding granting the scholarship for 2nd & 3rd years to those who have drawn it for the 1st year; in response, the Dean Research endorsed the above statement exclusively (i.e. granting subsequent extension for 2nd & 3rd years subject to submission of satisfactory performance and progress report of scholar from the concerned supervisor).
